Brush, roller or trowel: For inaccessible or awkward areas or when spray application

is not required or feasible.

For application of RA 208 (largest screened glassflake

polyester coating).

To obtain correct orientation of screened glassflake particles,

use a styrene-dipped roller.

LIMITATIONS

Pot life:

Vigilant care and attention to pot life is required during application. If gelling has started, do not apply.

Suitable only for coatings reinforced with 0.4mm (RA 264) and 0.8mm (RA 232) screened glassflake particles.

ENVIRONMENTAL CONDITIONS

Blasting or coating application should NOT be carried out when :-

Relative humidity is above 85% Air temperature < 5°C Steel temperature < 3°C above dew point of surrounding air.
